organizes in Pescara,

Sunday 17 MAY 2026, the 11th Maratonina del Mare / Pescara half marathon

Road race over a distance of 21.097 km included in the FIDAL NATIONAL calendar.

PROGRAM

- 1. Place and date: Pescara 17/05/2026
- 2. Type of race: Half Marathon 21.097 km FIDAL approved route
- 3. Race start: 9.00 am in front of the FLAIANO AMPHITHEATER
- 4. Arrival: at the FLAIANO AMPHITHEATER maximum time 3 hours
- 5. EXPO': FLAIANO AMPHITHEATRE from Saturday from 10.00 am to 7.00 pm.
- 6. Awards: first five overall M/F and the first three in category M/F

PARTICIPATION REQUIREMENTS

All those who meet one of the following requirements can participate:

ITALIAN ATHLETES

- 1. Italian athletes registered for 2026 with clubs affiliated with FIDAL (junior categories and over, male and female) or for a foreign Federation affiliated with World Athletic in compliance with IAAF regulations, who turn 18 years of age by 2026.
- 2. Italian citizens who are not FIDAL members in possession of a Runcard. Please note that this card is issued at the age of 20, therefore all citizens who have reached the age of 20 in the year of the event can participate in the half marathon, in the case of Runcard membership. The Runcard must ALWAYS be combined with a competitive medical certificate for athletics valid on 30/03/2026, which must be sent to the organizers according to the communication methods indicated in the "Information" section of these regulations.
- 3. Athletes registered with a Sports Promotion Body (Athletics Section) affiliated with FIDAL, in possession of Runcard-EPS and a competitive medical certificate for athletics valid as of 30/03/2026, which must be sent to the organizers.

Runcard and Runcard-Eps members must be at least 20 years old in the year of the event.

- 4. Paralympic athletes registered with the CIP;
- 5. Italian athletes residing abroad in possession of one of the following memberships:
 - 1. membership with clubs affiliated to Foreign Athletics Federations recognized by World Athletic by filling in and sending the appropriate Self-certification available in Annex A of these regulations;
 - 2. FIDAL membership valid for the 2026 season;
 - 3. RUNCARD membership (issued at the age of 20) ALWAYS combined with a valid competitive medical certificate for athletics, which must be sent to the organizers.







FOREIGN ATHLETES

- 1. Foreign athletes not resident in Italy can participate if they are registered with the Athletics Federation of the country of residence if recognized by World Athletic. This membership can be certified by means of the Self-certification form available in Annex A of these regulations to be sent completed and signed together with the registration form;
- 2. Foreign athletes, not resident in Italy, if not registered in their country of origin or in Italy, can participate by signing the Runcard (which can be purchased from the www.runcard.com website) and presenting a competitive medical certificate for athletics issued in their country of residence but compliant with the health regulations valid for competitive activity in Italy (Health Form available in Annex C of these regulations). Athletes who participate in this way must be at least 20 years old on the date of the event.
- 3. Foreign athletes, not resident in Italy who intend to run the marathon in a non-competitive way (SPORT TOURIST), can participate from the age of 20 onwards, even if they are not members of a club affiliated with Fidal or a foreign athletics club affiliated with World Athletic, by signing the appropriate release **form ANNEX B** of the registration form

Attention: By choosing this option, the athlete will be included in a separate report where he will see his time entered in alphabetical order and will not be able to benefit from prizes in kind or money.

In any case, the participant relieves ASD Run4Fun of any responsibility for his physical fitness to compete in the race and also declares that he has trained scrupulously and adequately.

PARTICIPATION REQUIREMENTS

For the Half Marathon: born from 2008 and earlier According to the provisions of the "Rules for the Organization of Non-Stadia Events" issued by FIDAL, athletes registered in Italy can participate limited to people from 18 years of age onwards (thousandth of age) in possession of one of the following requirements

- · Athletes registered for 2026 for FIDAL affiliated clubs
- Italian and foreign athletes in possession of a Runcard (valid as sports insurance and permission to compete) and athletes registered with a Sports Promotion Body (Athletics Section), in possession of a Runcard-EPS, limited to people from 20 years of age in possession of a valid medical certificate of specific competitive fitness for athletics, which must be compulsorily delivered, also digitally, to the organizing companies of each event.
- · Italian/foreign athletes not registered in Italy in possession of a club card affiliated to Foreign Athletics Federations recognized by World Athletic. At the time of registration, they must alternatively present the self-certification of possession of the card recognized by World Athletic. The self-certification must then, however, be signed in original at the time of collection of the bib.

The registered participant is responsible for the ownership and custody of his/her race bib, acquiring the right to use all the services mentioned in these regulations and subsequently communicated.

- Anyone, without regular registration, participates without a bib, in addition to being considered
 responsible for damage to persons or property, including himself, will incur sporting sanctions under the
 competence of the federal bodies and may be liable to the criminal sanctions provided for the crime of
 "theft" (Article 624. of the Criminal Code).
- 2. Anyone, without regular registration, participates with a counterfeit bib or in any case not in accordance with the assignment, in addition to being liable as indicated above, will incur sporting sanctions and, in addition, may be liable to the criminal sanctions provided for the crime of "theft" (Article 624 of the Criminal Code), or, alternatively, for the crime of "fraud" (Article 640 of the Criminal Code). In cases a) and b) participants may be liable to the penalties provided for the crime of "non-compliance with the provisions of the Authorities" (Article 650 of the Criminal Code).

The above cases will be verifiable only after verification photographic and/or video documentation.

CATEGORY AWARDS – the first 3 classified

Only those who arrived at the competitive race of the following male and female FIDAL categories will be entitled to category prizes: S35; S40; S45; S50; S55; S60; S65; S70 and above. Category prizes cannot be combined with the prize money for placement in the top 5 absolute positions.

1st in the Male and Female category € 40 2nd in the Male and Female category € 25 3rd in the Male and Female category € 15

The prizes must be collected on the day of the race at the awards ceremony in person, they will not be delivered to third parties or sent later, even if they are eligible. At the end of the race, with the amount of the prizes not collected, the organization will make a contribution to charity to the associations it deems appropriate

TIMING AND RANKINGS

The measurement of the times and the processing of the rankings is carried out by ENDU, the same are validated by the Official Judge, on the website www.endu.it

TIME LIMIT

The time limit to finish the race is set at 3 hours.

IT IS NON-REFUNDABLE

- 1. In this case, the athlete for any reason cannot participate in the race.
- 2. In the event that the race is CANCELLED for reasons beyond the control of the organizer, or in a greater form.
- 3. In the event that the registered athlete is unable to take part in the race can:

TRANSFER OF THE BIB

- Transfer registration to the 2026 edition as long as it is done by 15/04/2026, subject to payment of a supplement of € 5.00 for secretarial fees
- 5. It can only happen once It cannot be married more than once

RACE CHANGE from 21km, to 10km, or at another distance.

if the athlete registered for a race wants to change distance, subject to authorization of the organization, can do so but the difference in the quota will not be returned.

RACE PACK

The race pack can be collected both before the race and after the presentation of the bib. Real-time updates on the www.pescarahalfmarathon.it website

INFO HOTEL

The affiliated hotels can be booked on the official website of the event: www.pescarahalfmarathon.it in the HOSPITALITY section with the possibility of leaving the room at 13:00.

COMPLAINTS

Complaints must be made to the organization within 30 minutes of the display of the Rankings, accompanied by the fee of € 100 which will be refunded in case of acceptance of the complaint.

LIABILITY

The Athlete, by registering for the Maratonina del Mare, declares to accept the provisions of the aforementioned Regulations. For anything not foreseen, please refer to the FIDAL regulations.

The competitor also declares under his personal responsibility, not only to have declared the truth (art.2 law 04/01/1968 n.15 as amended by art.3 paragraph 10 law 15/05/1997n.127), but to exempt the organizers from any liability, both civil and criminal, for damage to persons and / or property caused by him or derived from him.

The organization, while taking care of the success of the event, declines any responsibility for any damage or injury that may occur to competitors, third parties and property, before, during and after the race and any responsibility for valuables or money left in exchange exchanges.

The athlete also declares that he/she registers voluntarily and assumes all risks deriving from his/her participation: falls, accidents of any kind, weather conditions. Releases and releases the "ASD Run4Fun", the promoting bodies and sponsors and all those connected to them, of all present and future claims or liabilities of any kind, unless this derives from their negligence or error. The race will take place in all weather conditions except for interventions by the authorities in charge in the event of a weather alert.







ROUTE / LIABILITY / ACCIDENTS

The organization, despite having checked the route and highlighted the various holes and imperfections of the asphalt with chalk for the care of the success of the event, the athlete must be careful because running in a group he can have the view of the course covered by the other athletes.

Any damage or injury that may occur, the athlete must apply to the FIDAL body by following this link.

IMAGE RIGHTS

By registering for the 11th Maratonina del Mare, the Athlete declares to know in full, to accept these Regulations and to exempt the organizers from any liability, both civil and criminal, for damage to persons and/or property caused by him or derived from him. The participating athletes must comply with the rules of the Highway Code." Pursuant to Legislative Decree No. 196 of 30/6/2003, before registration, the Athlete is required to read the documentation on the protection of privacy, available on the sito internet.

PRIVACY PROTECTION

The personal data provided to the organization through registration will be used, pursuant to Legislative Decree 196/03, to form the list of participants, the Rankings, for the services declared by the Regulations and for the sending of advertising and/or information material by the organization and/or its partners.

FINAL WARNINGS

The Organizing Committee reserves the right to modify these regulations at any time for reasons it deems appropriate for a better organization of the race. Any changes after approval by FIDAL will be appropriately communicated to the registered athletes or will be reported on the www.pescarahalfmarathon.it website.
